**TRANSFER OF PROGRAM ADMINISTRATION AND MANAGEMENT OF
CONTRACTING ARRANGEMENT PURSUANT TO ARTICLES 106 TO 109, OF THE
LABOR CODE AS AMENDED, AND ITS IMPLEMENTING RULES AND
REGULATIONS FROM THE BUREAU OF WORKING CONDITIONS TO THE
BUREAU OF LOCAL EMPLOYMENT**

Following Administrative Order No. 08, Series of 2023, the program administration and management of contracting arrangements, pursuant to Articles 106 to 109 of the Labor Code, as amended, as well as its Implementing Rules and Regulations (IRR), have been transferred from the Bureau of Working Conditions (BWC) to the Bureau of Local Employment (BLE).

The BLE shall act on the request letter for non-coverage based on the nature of the business and contractual relationship consistent with other applicable laws, rules and regulations, as provided under Department Circular No. 01, Series of 2017 (*Clarifying the Applicability of Department Order No. 174, Series of 2017*).

Other functions delegated under Department Order 174, Series of 2017, such as processing applications for registration, the conduct of inspections, revocation or cancellation of registration, monitoring, and reporting, among others, shall continue to be performed by the appropriate DOLE Regional Office.
